
INTRODUCTION

Textile fibers of vegetal, animal, or artificial origin have always been used as raw materials for the production of clothing throughout the world.

Cotton fiber is a strategic product for several Member States of the Organization of Islamic Cooperation (OIC). It represents more than 20% of the export earnings of some States and employs more than 30% of the working population. As such, the Cotton-Textile sector occupies a prominent place in the economic and social development of our States.

However, the issues of cotton subsidies provided by some countries are likely to lower the price of the fiber on the international market and drastically reduce the revenues related to these exports.

The world cotton trade volume amounts to 114.5 billion USD in 2021 against 106.2 billion USD in 2017, i.e. an increase by 7.8% due to the fluctuation of its prices on the world market. The OIC Member States have totaled a cotton trade volume of about 32.6 billion USD in 2021 against 26.6 billion USD in 2017, i.e. an increase by 22.6% during this period. More than a quarter of the world cotton trade comes from OIC countries between 2017 and 2021, particularly from African countries and Central Asia.



On the other hand, intra-OIC cotton trade reached 9.8 billion USD in 2021 against 7.3 billion USD in 2017, i.e. an increase by 33.5% during the last four years thanks to the increase in trade of African and Asian countries. Between 2017 and 2021, the share of intra-OIC cotton trade is around 30%.


In fact, the main exporters of cotton in 2021 to the OIC Area are: Pakistan, Uzbekistan, Turkey, Benin, Turkmenistan, Azerbaijan, Côte d'Ivoire, Egypt, Tajikistan and Indonesia, which have totaled more than 87% of the world exports of Member States, i.e. a value of 4.4 billion USD. As for the importers of the OIC countries, we can mention: Turkey, Bangladesh, Pakistan, Tunisia, Iran, Morocco, Egypt, Indonesia, United Arab Emirates and Malaysia for the need of their textile industries and manufactures. This top-ten recorded a value of 4.6 billion USD in 2021 or 97% of the world imports of the OIC Member States.


The main products traded are cotton at 67% and processed textile products at 33% in 2021.

Considering the low level of cotton processing in OIC countries, the organization of this Trade Fair and Forum on the sector will help boost intra-OIC trade.

In this context, the transformation of cotton fiber and its derivatives through the creation of sustainable value-added activities in the cotton-textile-clothing value chain is becoming a major issue at the heart of the economic and social development of our countries.


The promotion of income-generating activities for women and youth should be placed at the center of this issue in order to have a sustainable impact on the inclusive development of our economies.



GENERAL DESCRIPTION OF THE ISLAMIC COUNTRIES EXHIBITION


The main objective of the exhibition is to promote products from the Cotton-Textile-Clothing value chain. Additionally, it will

emphasize the contribution of women and young people in the processing of products in the sector, particularly in the field of production of soaps, oil, oilcake, thread for weaving and printing, and clothing fashion. All African cotton-producing countries and those from the OIC are invited to take part in this crucial promotional event.

It is worth mentioning that the 2^{nd} edition of the Cotton, Textile, and Clothing exhibition will welcome the presence of many renowned figures in the business world from public and private domains.

THE OBJECTIVES OF THE EXHIBITION ON COTTON, TEXTILES, AND CLOTHING

ICDT, Regional Council for the Promotion and Development of Crafts and SMEs (CRAPME), and the Cotton and Cashew Council have defined objectives within the framework of the organization of the 2nd edition of the exhibition on cotton, textiles, and clothing of the OIC Member States from October 19 to 23, 2022.

- Working for the deployment of exhibitions and congresses as a marketing tool among member countries.

Exhibitors are provided with fluid and energy facilities so that their machines and installations can be exhibited in operation.

All halls have a concrete floor to support all tonnages.

Connections on request: Electricity 220 / 380 Volts, Water, Compressed air, Telephone, Internet.

THE TREICHVILLE SPORTS PALACE

The construction of the Palais des Sports de Treichville dates back to 1978 in Côte d'Ivoire. It is a covered room with an area of 4,500 m² of exhibition space.

HOW TO ACCESS IT

The Palais des Sports Treichville is located in the Abidjan town of Treichville next to the sports park.

CONDITIONS OF PARTICIPATION


The Ivorian authorities grant incentives in the form of tariff and non-tariff facilities for the entry of products and people. Interestingly, preferential rates on transport, freight, accommodation, and transit are also negotiated with service providers in accordance with the regulations in force in the Republic of Côte d'Ivoire.

PARTICIPANTS

The exhibition is open to the participation of the 57 Member States of the OIC and the various economic, public, and private operators of Islamic countries.

States having observer status within the OIC can also take part in this exhibition, economic operators of Islamic communities from non-member countries as well as guests of honor.

REGISTRATION CONDITIONS



The amount of the participation is fully due upon signature of the participation form. If the invoice is not paid 15 days before the opening of the exhibition, the organizers may consider the participation commitment automatically terminated and simply prohibit the exhibitor's admission to the exhibition.

The exhibitor shall nevertheless remain liable to the organizers for the full amount of his commitment.

EXHIBITED PRODUCTS

The products and services to be exhibited must:

- a. Be from the origin of OIC Member States as defined by:
 - o Trade agreements to which Côte d'Ivoire and the OIC Member State are parties;


- National regulations for other countries that are not members of the abovementioned trade agreements.
- b. Consistent with the ethics and values of Islam.
- c. The products to be exhibited are subject, where applicable, to sanitary, phytosanitary, and environmental controls, in accordance with the regulations in force in Côte d'Ivoire.

FACILITIES GRANTED TO PARTICIPANTS

The Republic of Côte d'Ivoire will grant the participants of the exhibition the following facilities:

- Preferential tariffs on freight, accommodation, and transit are granted by the concerned service providers;
- A business contact facilitation platform;
- B2B meetings on the cotton industry and textile and clothing products;
- Panels on cotton.





ORGANIZATION AND DATES

The exhibition will be held from October 19 to 23, 2022. It will be open from 10:00 a.m. to 6:30 p.m.

The installation of the Stands will take place from Monday, October 17, 2022, from 9 a.m. to 7 p.m.

PAYMENT

Payment for the Stand is due upon signature of the participation request by bank transfer.

The total amount of the exhibitor's participation fees is due 15 days before the opening of the event.

RESERVATION AND LAYOUT OF STANDS

The reservation of the stands will be made no later than Monday, October 10, 2022

Stands will be set up from Monday, October 17, 2022, from 9:00 a.m. to 7:00 p.m. until Tuesday, October 18, 2022, at 8:00 p.m.

Stands are installed and equipped with a module of 9 m².

The standard unfurnished stand of 9 m2 includes:

- Aluminum structure
- Dividing panels
- Front panel

- Signage panel
- 1 projector of 150 W
- 1 x 400 W power outlet
- Carpeting

The technical services of the CRAPME of Côte d'Ivoire will provide participants with accurate plans of the location reserved for them. However, it is up to the exhibitors to make sure of their conformity or to ask their local representative (agent, installer) to make the necessary checking.


In case of necessity, the organizers may move a participant or assign him/her to another site corresponding to his activity, provided that this modification will not result in any compensation.

RENUNCIATION

Renunciations that will be received after confirmation of the location will not result in any refund: the sums paid are intended to cover the administrative and technical costs already incurred by the organizers.

If the renunciation occurs before the confirmation of the location, the sums paid will be reimbursed after adeduction of twenty-five percent (25%) of the rental price of the stand as administrative penalties, renunciations must be sent by registered mail to the exhibition administration.

PRESENCE AT THE STAND



Exhibitors are required to maintain a permanent delegate at the booth who is qualified to conduct business.

Exhibitors and stand managers are responsible for the conduct and actions of the staff attached to their services.

PROHIBITION

It is strictly forbidden to put highly flammable products, weapons, and narcotics in the stands.

The use of music chains for advertising is also prohibited on the stands and may result in the seizure of the equipment.

Therefore, the organizers plan to put at the disposal of the interested exhibitors, a podium of animation as well as spaces of paying visibility.

The transfer or subletting of all or part of the stand or site is forbidden.

However, with a written agreement from the organizers, several participants may jointly occupy the same stand.

The exhibitors may organize various scientific events and national days, with the approval of the exhibition administration.

Nevertheless, some prohibitions will have to be respected, under penalty of immediate exclusion from the exhibition without notice, namely:

- To distribute samples or flyers outside the stands;
- To make, to attract the customer, any noisy demonstration or advertising likely to disturb the participants of the neighboring stands and the visitors;
- To place the objects in projection, on the external face of the stand;
- To damage, in any way whatsoever, the equipment made available to them.

In addition, it is strictly forbidden for exhibitors to leave staff in the stands outside the opening hours of the Exhibition, except for the guards provided by the approved companies.

INSURANCE

By signing the application for participation in the Cotton, Textile, and Clothing exhibition of the OIC Member States which will be organized from October 19 to 23, 2022, each exhibitor adheres to CRAPME's insurance policies covering civil liability and fire.

Theft is not covered by insurance.

In the event of a loss, exhibitors cannot claim any compensation from CRAPME beyond that granted by CRAPME's insurer.

SECURITY


The Administration of the Regional Council for the Promotion and Development of Crafts and SMEs is responsible for the security and maintenance of the exhibition premises during the exhibition period. To this end, it declines responsibility for specific missions entrusted to individuals.

To avoid any commercial espionage, the exhibition administration leaves it up to each exhibitor to protect himself legally and under his responsibility against those who would like to photograph the stands, pavilions, or locations and use the pictures in their advertising brochures and leaflets.

PARTICULAR MEASURES

The exhibitor formally undertakes to comply with all the clauses of these regulations, which are strictly enforceable and may not be considered mere guidelines.

The exhibitors and the managers of the stands or pavilions are responsible for the behavior and all the actions of their staff.



The Exhibition Organizers decline all responsibility regarding the behavior of the employees of the exhibitors.

The Exhibition Organizers are empowered to expel any undesirable person and, in general, to take any measure to preserve the smooth running and good reputation of the Exhibition, including the filing of a claim for damages or any legal action.

JURISDICTION

In case of dispute, only the Ivorian courts will be competent to judge. No derogation will be accepted from this jurisdiction clause.

Participant certificates, signed by the commissioners of the exhibition, will also be given to all exhibitors.




