Meksika'nın 15.08.2023 tarihli İthalat ve İhracat Genel Vergileri Kanunu Tarifesinde değişiklik ile çelik, alüminyum, bambu, kauçuk, kimyasal ürünler, tekstil, konfeksiyon ve ayakkabı, seramik mamulleri, cam, elektrik malzemeleri, müzik aletleri, mobilya, kağıt ve karton ürünlerini içeren 392 GTİP'te 5%-25% arasında değişen oranlarda gümrük vergisi tesis ettiği bildirilmekte olup, İspanyolca aslına aşağıdaki linkten ulaşılabilen ilgili Kararname metninin Meksiko Ticaret Müşavirliğince yapılan gayriresmi İngilizce tercümesi ilişik bulunmaktadır.

DECREE by which the Tariff of the Law of General Import and Export Taxes is modified.

On the margin a stamp with the National Shield, which says: United Mexican States-Presidency of the Republic.

ANDRÉS MANUEL LÓPEZ OBRADOR, President of the United Mexican States, in exercise of the power conferred on me by article 89, section I, of the Political Constitution of the United Mexican States, based on articles 131 of the Constitution; 31 and 34 of the Organic Law of the Federal Public Administration, and 2nd, 4th, section I, and 12 of the Foreign Trade Law, and

CONSIDERING

That article 25, first paragraph, of the Political Constitution of the United Mexican States (CPEUM) establishes that "the State is responsible for the rectory of national development to guarantee that it is comprehensive and sustainable, that it strengthens the Sovereignty of the Nation and its regime democratic and that, through competitiveness, the promotion of economic growth and employment and a fairer distribution of income and wealth, allows the full exercise of freedom and dignity of individuals, groups and social classes";

That article 131, second paragraph, of the CPEUM grants the Federal Executive the extraordinary power to increase, decrease or suppress the quotas of export and import tariffs issued by the Congress of the Union, and to create others, as well as to restrict and prohibit imports, exports and transit of products, articles and effects, when deemed urgent, in order to regulate foreign trade, the country's economy, the stability of national production or to carry out any other purpose, for the benefit of from the country;

That the General Agreement on Customs Tariffs and Trade, which is part of the Marrakesh Agreement establishing the World Trade Organization, whose promulgatory decree was published in the Official Gazette of the Federation (DOF) on December 30, 1994, allows members to make adjustments to their import tariffs to the extent that these do not exceed those set in the list of concessions agreed within the framework of said organization;

That the General Axis III. Economy of the National Development Plan 2019-2024, published in the DOF on July 12, 2019, establishes in its objective "To promote economic reactivation, the internal market and employment" that one of the central tasks of the current federal government is to promote economic reactivation and getting the economy to grow again at acceptable rates, which requires the strengthening of the internal market;

That the "Decree establishing various Sectoral Promotion Programs", published in the DOF on August 2, 2002 and its subsequent amendments, is intended to grant the national productive industry better supply conditions for inputs and machinery, as well as mechanisms to exercise a greater participation in the markets by establishing competitive tariff conditions that allow access to strategic inputs that national industries use in their production processes, in conditions similar to those that their competitors have abroad;

That the "Decree that modifies the Tariff of the General Import and Export Tax Law, the Decree that establishes the general import tax for the border region and the northern border strip, the Decree

for the establishing various Sectoral Promotion Programs and the Decree for the Promotion of the Manufacturing, Maquiladora and Export Services Industry", published in the DOF on September 20, 2019, established the import tariff of 15% for merchandise classified in 228 tariff fractions of the steel sector with a medium-term tariff reduction scheme that ends on August 22, 2024, in order to create a favorable environment that would allow the steel industry to adjust to the international economic context, encourage the domestic market and define a tariff policy in the medium and long term;

That the "Decree by which the Tariff of the General Import and Export Tax Law is modified", published on October 28, 2019 in the DOF, establishes, until September 30, 2024, the import tariff to 43 tariff fractions of the footwear sector and 274 tariff fractions of the textile and clothing sectors, in order to provide certainty to said sectors and support the domestic market;

That the "Decree by which the Tariff of the General Import and Export Tax Law is modified, the Decree to support the competitiveness of the automotive terminal industry and the promotion of the development of the internal automobile market, the Decree establishing the general import tax for the border region and the northern border strip, the Decree establishing various Sectoral Promotion Programs and the various ones establishing quota-tariffs", published in the DOF on December 24, 2020, among other measures, created and modified tariff fractions in which merchandise from the steel sector indicated in the decree published on September 20, 2019 are classified, and extended the completion date of the tariff reduction to September 30 from 2024;

That the "Decree by which the Tariff of the General Import and Export Tax Law is modified", published on November 22, 2021 in the DOF, established, until June 29, 2022, a tariff of 15 % to the import of merchandise classified in 112 tariff fractions corresponding to the steel sector, and the medium-term tax relief scheme provided for in the decree published in the aforementioned official dissemination body on December 24, 2020 referred to above, with the purpose of establishing favorable conditions for the recovery of the Mexican steel industry, since the context and global situation of the steel market that motivated the establishment of the temporary tariff continued, as well as the international economic situation derived from the adverse effects of the pandemic caused by the SARS-CoV-2 virus (Covid-19);

That the "Decree by which the Law of General Import and Export Taxes is issued", published on June 7, 2022 in the DOF, establishes in its article 10. the quotas of the tariff of said law that attend to the classification of the merchandise, and serve to determine the general taxes of import and export;

That the "Decree by which the diverse by which the Tariff of the General Import and Export Tax Law is modified, published in the Official Gazette of the Federation on November 22, 2021", published in the DOF on June 29, 2022, extended, until May 31, 2023, the validity of the temporary tariff of 15% for various steel products and maintained the tax relief scheme established in the decree published in the aforementioned official dissemination body on June 22. November 2021;

That the "Decree by which the Tariff of the General Import and Export Tax Law is modified, the Decree to support the competitiveness of the automotive terminal industry and the promotion of the development of the internal automobile market, the Decree for the Promotion of the Manufacturing, Maquiladora and Export Services Industry, the Decree establishing the general import tax for the border region and the northern border strip, the Chetumal Free Zone Decree, the

Decree for the establishing various Sectoral Promotion Programs, the Decree regulating the definitive import of used vehicles and the various ones establishing tariff-quotas", published in the DOF on November 18, 2022, modified various instruments to update them in accordance with the new rate of the General Import and Export Tax Law, published in the DOF on June 7, 2022, in order to provide legal certainty to foreign trade users, which include the measures established in the various instruments referred to above, related to tariff fractions of the steel, footwear, textile and clothing sectors, among others;

That in the second and third articles of the decree mentioned in the previous recital, a temporary tariff of 15% was established for the import of goods classified in 112 tariff fractions related to various products of the steel sector, with a tariff reduction scheme until 1 October 2024, and 20% for the import of merchandise classified in 91 tariff items related to the textile, clothing and footwear sectors, effective as of October 1, 2024;

That, in relation to the steel sector, at the 93rd session of the Steel Committee of the Organization for Economic Cooperation and Development, held on March 13 and 14, 2023, it was reported that there is still excess global production capacity steel, which aggravates the pressures to dispose of production surpluses;

That, in recent years, various sectors of the national industry, including textiles, clothing and footwear, have been affected by the slowdown in economic growth derived from the pandemic caused by the SARS-CoV-2 virus (Covid-19);

That the federal government has the obligation to implement the mechanisms that generate stability in the sectors of the national industry and that allow the elimination of distortions in trade, to safeguard the balance of the global market in accordance with international law and international commitments;

That, derived from the foregoing, it is convenient to establish temporary import tariffs, between 5% and 25%, of merchandise classified in 392 tariff items related to steel, aluminum, bamboo, rubber, chemical products, oils, soap, paper, cardboard, ceramic products, glass, electrical material, musical instruments and furniture, among others, in order to provide certainty and fair market conditions to all sectors that face situations of vulnerability as well as allow the recovery of the national industry, promote its development and support the domestic market;

Due to the fact that the textile and footwear sectors also face situations of vulnerability, for the purpose indicated in the previous recital, it is advisable to maintain the import tariffs that currently apply to said merchandise, thus eliminating the planned tariff reduction scheme in the decree published in the DOF on November 18, 2022 referred to above;

That, in order to avoid affecting the productive chains and to maintain competitiveness in the most sensitive industrial sectors such as electrical, electronic, automotive and auto parts, it is necessary to maintain, for the same period of validity of the tariffs provided for in this decree, the tariff benefit of the Sectoral Promotion Programs applicable to tariff fractions of various steel products, and

That, in accordance with the provisions of the Foreign Trade Law, the tariff measures referred to in this decree have the opinion of the Foreign Trade Commission, I have had the good will to issue the following

DECREE

Single Article. The tariffs of the tariff fractions of the Tariff of the General Import and Export Tax Law, published in the Official Gazette of the Federation on June 7, 2022 and its subsequent modifications, **are temporarily modified**, which are indicated below:

TRANSIENT

First. This decree enters into force on August 16, 2023 and ends its validity on July 31, 2025.

In the case of the import of merchandise classified in tariff items 7210.70.02 and 7212.40.04 from the entry into force of this decree and until December 31, 2023, a tariff of 10% will be applied, and from January 1, 2024 and until July 31, 2025, the tariff provided for in the sole article of this decree will be applied.

Second. The Second and Third articles, and the Second, Third and Sixth transitory articles of the "Decree amending the Tariff of the General Import and Export Tax Law, the Decree to support the competitiveness of the industry" are repealed. automotive terminal and the promotion of the development of the domestic automobile market, the Decree for the Promotion of the Manufacturing Industry, Maquiladora and Export Services, the Decree establishing the general import tax for the border region and the border strip North, the Chetumal Free Zone Decree, the Decree establishing various Sectoral Promotion Programs, the Decree regulating the final importation of used vehicles and the various ones establishing quota-tariffs", published in the Official Gazette of the Federation on November 18, 2022.

Third. For the purposes of the "Decree establishing various Sectoral Promotion Programs", published in the Official Gazette of the Federation on August 2, 2002 and its subsequent modifications, from the entry into force of this ordinance and until the July 31, 2025, the programs referred to in sections I, II and XIX of article 5 of said decree include the following tariff sections:

I. In the electrical industry program, tariff sections 7208.39.01, 7208.51.04 and 7211.29.99;

- II. In the electronic industry program, tariff fraction 7225.19.99, solely for the purposes of fraction II, subparagraph b, of article 5 of the decree referred to in this transitory, and
- III. In the programs of the automotive and auto parts industries, tariff items 7208.26.01, 7208.27.01, 7209.16.01, 7209.17.01, 7211.29.99, and 7225.30.91 and 7225.40.91.
