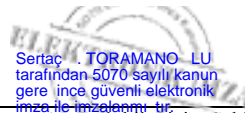
T.C. Ticaret Bakanlığı İthalat Genel Müdürlüğünden alınan 20/11/2023 tarih 00091153178 sayılı yazıda;

Endonezya tarafından “**Halllar ve Tekstilden Diğer Yer Kaplamaları**” (57’nci fasılda yer alan) ithalatına karşı, 17 Şubat 2021 tarihinden bu yana uygulanan korunma önleminin uzatılmasına ilişkin olarak bir gözden geçirme soruşturmasının yürütüldüğü hatırlatılarak söz konusu soruşturmaya ilişkin olarak Endonezya tarafından yapılan ve ilişkide yer alan 9 Kasım 2023 tarihli Dünya Ticaret Örgütü (DTÖ) bildiriminde, Endonezya Hükümeti tarafından söz konusu korunma önleminin **3 yıl daha uzatılmasının planlandığı** ve bu çerçevede **17 Şubat 2024 tarihinden itibaren 3 yıl boyunca spesifik vergi şeklinde metrekare başına ilk yıl 74,461 Rp., ikinci yıl 71,058 Rp., üçüncü yıl 67,811 Rp. olarak uygulanmasının öngörüldüğü** ve kesin kararın verilmesinin ardından söz konusu kararın ayrıca bildirileceği ifade edilmektedir.

**NOTIFICATION UNDER ARTICLE 12.1(B) OF THE AGREEMENT ON  
SAFEGUARDS ON TAKING A DECISION TO APPLY A SAFEGUARD MEASURE**

INDONESIA

*Carpets and Other Textile Floor Coverings*

*Supplement*

The following communication, dated and received on 9 November 2023, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 7.2 and Article 12.1(b) of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia, hereby notifies the Committee on Safeguards of the investigation findings concerning the extension of a safeguard measure against the importation of Carpets and Other Textile Floor Coverings.

**1 EVIDENCE THAT THE SAFEGUARD MEASURE CONTINUES TO BE NECESSARY TO  
PREVENT OR REMEDY SERIOUS INJURY OR THREAT THEREOF AND THAT THE INDUSTRY  
CONCERNED IS ADJUSTING**

The Government of the Republic of Indonesia initiated an investigation on the extension of a safeguard measure on 18 August 2023 ([G/SG/N/6/IDN/35/Suppl.1](#)). The scope of the investigation was to decide whether the safeguard measure should be extended or not.

To determine whether the safeguard measure continues to be necessary to prevent or remedy serious injury or threat thereof and whether the industry is adjusting, the Investigating Authority (*Komite Pengamanan Perdagangan Indonesia/KPPI*) undertook a comprehensive analysis of a broad set of data from multiple sources: the evidence provided by the Applicant's member industries in their questionnaire replies and written submissions, the information provided by interested parties (importers, exporters, and other interested parties) in their written submissions, as well as information available to the Investigating Authority including statistical databases and relevant publications.

**1.1 Economic performance of the Applicant**

To assess the economic performance of the Applicant, the developments of imports, and other relevant data included in its assessment, the Investigating Authority assessed the data for the period 2020-2022 ("the investigation period").

- The Applicant's production decreased with a trend of 0.15% during the investigation period. The Applicant's production increased by 2.89% from 100 indexed point in 2020 to 102.9 indexed point in 2021 due to an increase in national consumption. Meanwhile, the Applicant's production decreased by 3.09% from 102.9 indexed point in 2021 to 99.7 indexed point in 2022.
- The Applicant's domestic sales decreased with a trend of 1.40% during the investigation period. The Applicant's domestic sales increased by 4.51% from 100 indexed point in 2020 to 104.5 indexed point in 2021. However afterward, the Applicant's domestic sales decreased by 6.97% from 104.5 indexed point in 2021 to 97.2 indexed point in 2022, due to the flood of imported goods from Viet nam, Malaysia, and Thailand which were previously exempted from the safeguard measure imposition.
- The Applicant strives to maintain its productivity levels and achieve a trend increase of 1.72%, by reducing the employment by 1.46% and 2.22 in 2021 and 2022, respectively.
- During the investigation period, the Applicant's utilization capacity decreased with a trend of 0.15%. The Applicant's utilization capacity increased by 2.89% from 100 indexed point in 2020 to 102.9 indexed point in 2021. Furthermore, the Applicant's utilization capacity decreased by 3.09% from 102.9 indexed point in 2021 to 99.7 indexed point in 2022.
- During the investigation period, the Applicant continued to experience a decline in profits with a trend of 11.77%. The decrease in profit was due to an increase in imports of the subject good in the domestic market.
- During the investigation period, the Applicant's employment decreased with a trend of 1.84%. This reduction in employment was due to the Applicant's effort to achieve cost efficiency.
- During the investigation period, the Applicant's inventory increased with a trend of 4.59%. The Applicant's inventory decreased by 2.43% from 100 indexed point in 2020 to 97.6 indexed point in 2021. Meanwhile, the Applicant's inventory increased by 12.12% from 97.6 indexed point in 2021 to 109.4 indexed point in 2022.

During the investigation period, the Applicant's market share decreased with a trend of 7.11% and both the Non-Applicant's market share and import's market share increased with a trend of 15.49% and 15.50% respectively. Even though the Non-Applicant's market share has increased, the consolidated data of both the Applicant's and Non-Applicant's market share has decreased with a trend of 1.40% during the investigation period.

## 1.2 Evidence that the industry concerned is adjusting

The domestic industry has conducted adjustment plans aiming at increasing its product innovation, installing new machinery production, and increasing employment skills. The realization of the structural adjustment program that has been carried out by the Applicant is as follows:

Based on the table above, both imports in absolute and relative terms to the national production experienced an increase during the period of 2020-2022, with trends of 22.60% and 22.57%, respectively

The proposed measure is in the form of a specific duty.

## 6 PROPOSED DATE OF INTRODUCTION OF THE MEASURE

The proposed extension of the safeguard measure will come into effect on 17 February 2024.

## 7 EXPECTED DURATION OF THE MEASURE

The expected duration of the proposed extension of the safeguard measure is three years.

## 9 EXPECTED TIMETABLE FOR PROGRESSIVE LIBERALIZATION OF THE MEASURE

The measure will continue being progressively liberalized, at regular intervals, at the beginning of each period of application as follows:

## 10 IF THE NOTIFICATION RELATES ONLY TO A FINDING OF SERIOUS INJURY OR THREAT THEREOF, AND DOES NOT RELATE TO A DECISION TO APPLY OR EXTEND A SAFEGUARD MEASURE

Pursuant to Article 7.2 and Article 12.1(b) of the WTO Agreement on Safeguards, The Government of the Republic of Indonesia hereby notifies the investigation findings concerning the extension of safeguard measures against the importation of Carpets and other textile floor coverings. This notification is made only for the findings of the investigation. Once the decision to extend the safeguard measure is made, it will be notified under Article 12.1(c) of the Agreement on Safeguards.

## 11 INFORMATION RELATING TO THE EXTENSION OF A SAFEGUARD MEASURE

### 11.1 Evidence that the industry concerned is adjusting and that the safeguard measure continues to be necessary to prevent or remedy threat of serious injury

### 11.2 Reference to the WTO document that notified the initial application of the measure

Pursuant to Article 12.1(c) of the WTO Agreement on Safeguards, on 17 February 2021, the Government of the Republic of Indonesia notified the Committee on Safeguards regarding the decision to impose safeguard measures on the imports of Carpets and other textile floor coverings ([G/SG/N/8/IDN/27/Suppl.1](#) - [G/SG/N/10/IDN/27/Suppl.1](#) - [G/SG/N/11/IDN/24](#)).

### 11.3 Duration of the measure from initial application till the date at which it will be extended

The initial definitive safeguard measure is imposed for 3 years, from 17 February 2021 until 16 February 2024. The extension of the safeguard measure is proposed to be imposed for 3 years, until 16 February 2027.

### 11.4 Precise description of the measure in place prior to the date of extension

The initial definitive measure was notified on 17 February 2021 ([G/SG/N/8/IDN/27/Suppl.1](#) - [G/SG/N/10/IDN/27/Suppl.1](#) - [G/SG/N/11/IDN/24](#)).

## 12 INFORMATION RELATING TO EXPORTING MEMBERS THE MAJOR EXPORTING MEMBERS OF IMPORTS OF THE PRODUCT INVOLVED

The main exporting countries of the product concerned are Viet Nam, Türkiye, Malaysia, Japan, the People's Republic of China, and Thailand.

**12.1 If there are any exporting Members to which the measure does not apply for any reason other than the application of Article 9.1, the names of such exporting Members and reasons for non-application of the measure**

**13 INVITATION OF CONSULTATIONS**

In accordance with Article 12.3 WTO Agreement on Safeguards the Government of the Republic of Indonesia is open for consultation in order to provide opportunities for those Members, consultation is scheduled to be held virtually no later than 1 December 2023.
