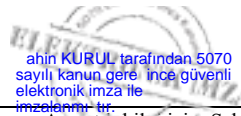

**SUBJECT : IMPOSITION OF PRICE-BASED SPECIAL SAFEGUARD (SSG) MEASURE ON SEVERAL AGRICULTURAL PRODUCTS**

Pursuant to Republic Act (RA) No. 8800, otherwise known as the "Safeguard Measures Act", the Secretary of Agriculture hereby requests the Commissioner of Customs, through the Secretary of Finance, for the imposition or continuation of the imposition of the price-based Special Safeguard (SSG) measure on the following agricultural products eligible for such measure:

Additional duty should be collected for imports of the above-mentioned products if their cost, insurance, and freight (CIF) import prices breach their respective trigger prices, i.e. the actual CIF price of each product at the time of lodgment of import documents is less than its corresponding trigger price, pursuant to Section 24 of RA 8800.

Amending for this purpose Department Order No. 16, s.2024.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
