T.C. Ticaret Bakanlığı İthalat Genel Müdürlüğünden alınan 04/09/2025 tarih 113184377 sayılı yazıda;

Amerika Birleşik Devletleri (ABD) tarafından Meksika ve ülkemiz menşeli “İnşaat Demiri” (7213.10, 7214.20 ve 7228.30 gümrük tarife istatistik pozisyonunda yer alan) ithalatına karşı 2014 yılından bu yana sübvansiyona karşı telif edici önlem uygulandığı hatırlatılmakta olup, Dünya Ticaret Örgütü (DTÖ) Sübvansiyonlar ve Telif Edici Önlemler Anlaşması’nın ilgili hükümlerine göre ABD makamları tarafından önlemin devamının gerekliliğini incelemek amacıyla 2 Eylül 2025 tarihi itibarıyla nihai gözden geçirme soruşturmasının (sunset review) başlatıldığı, mezkur soruşturmalar sonucunda bahse konu önlemin yürürlükten kalkması ihtimal dahilinde olduğu, ABD’nin ilgili mevzuatları uyarınca sübvansiyon soruşturmalarında sübvansiyonun mevcudiyeti ile zararın mevcudiyeti iki ayrı kurum tarafından incelendiği ve ABD Ticaret Bakanlığı (DOC) Uluslararası Ticaret İdaresi (ITA) tarafından sübvansiyonun mevcudiyetine yönelik, Uluslararası Ticaret Komisyonu (ITC) tarafından ise mevcut sübvansiyon uygulamalarının ABD yerli üretimine zarar verip vermediğine yönelik ayrı soruşturmaların yürütüldüğü belirtilmektedir.

Yazıda ayrıca, adı geçen ABD’li kurumlar tarafından 2 Eylül 2025 tarihli ABD Resmi Gazetesi’nde yayımlanan ve birer örneği ilişik bulunan bildirimlerle ülkemiz menşeli “İnşaat Demiri” ithalatına karşı uygulanmakta olan Sübvansiyona karşı telif edici önleme yönelik nihai gözden geçirme soruşturmasının (sunset review) başlatılmış bulunduğu, bahse konu açılış bildirimlerinin incelenmesinden de anlaşılabileceği üzere, bu süreçte ITA ve ITC, ilgili taraflarca verilen cevapların “yeterli” olup olmadıklarının incelenmesini müteakip bir “tam gözden geçirme soruşturması” (full review) veya bir “hızlandırılmış gözden geçirme soruşturması” (expedited review) yürütülmesine karar vermekte olduğu, bahse konu cevapların yeterli sayılabilmesi için normalde ülke hükümetinin yanı sıra, soruşturma konusu ürün ihracatçısı firmaların (soruşturma açılışından önceki son 5 sene içerisinde ABD’ye gerçekleştirilen soruşturma konusu ürün ihracatının en az %50’sini gerçekleştiren firmaların) da nihai gözden geçirme soruşturmasına taraf olmasının gerektiği bildirilmektedir.

İhracatçı ülke hükümeti ile firmaların soruşturmaya taraf olmaması ya da taraf olmalarına rağmen verdikleri cevapların “tam ve kapsamlı” (complete substantive responses) niteliği bulunmaması durumunda, ABD otoritelerince “tam gözden geçirme soruşturması” (full review) yerine “hızlandırılmış gözden geçirme soruşturması” (expedited review) yürütülmesine karar verilebilmekte olduğu, hızlandırılmış gözden geçirme soruşturmasının yürütülmesi durumunda, mezkur otoriteler soruşturmaya ilişkin kararlarını “mevcut en iyi bilgilere” (facts available) dayanarak almakta olduğu, bu çerçevede firmalarımızca, soruşturmaya taraf olunması ve cevaplandırılması gereken soruların yanıtlandırılması büyük önem arz etmekte olduğu, bu itibarla, sübvansiyonun mevcudiyetini değerlendirecek olan ITA’nın yürüteceği soruşturmaya taraf olmak isteyenlerin, soruşturma açılış bildiriminin ABD Resmi Gazetesi’nde yayımlanmasından itibaren (2 Eylül 2025) en geç 10 gün içerisinde ITA ile temasa geçerek soruşturmaya taraf olma niyetlerini yazılı olarak sunmalarının gerektiği, taraf olunmasını müteakip ilgili tarafların “tam ve kapsamlı” (complete substantive responses) yanıtlar sunabilmeleri için soruşturma açılış bildiriminin ABD Resmi Gazetesi’nde yayımlanmasından itibaren (2 Eylül 2025) 30 gün içerisinde ABD’nin 19 CFR 351.218 (d)(3) simgeli mevzuatında yer alan soruları yanıtlayarak ABD makamlarına sunmalarının gerektiği, ayrıca, zararın mevcudiyetini değerlendirecek olan ITC’nin yürüteceği soruşturmaya taraf olmak isteyenlerin soruşturma açılış bildiriminin ABD Resmi Gazetesi’nde yayımlanmasından itibaren (2 Eylül 2025) 21 gün içerisinde ITC ile temasa geçerek soruşturmaya taraf olma niyetlerini yazılı olarak sunmaları ve 2 Ekim 2025 tarihine kadar ise ekte kayıtlı Resmi Gazete’de yayımlanan soruları cevaplayarak ITC’ye iletmeleri gerektiği ifade edilmektedir.

Bu bağlamda, soruşturmaya taraf olacak firmaların Ticaret Bakanlığına iletmek üzere 9 Eylül 2025 Salı günü mesai saati bitimine kadar Genel Sekreterliğimize bilgi vermeleri gerekmektedir.

that interested parties limit their public executive summary of each issue to no more than 450 words, not including citations. We intend to use the public executive summaries as the basis of the comment summaries included in the decision memorandum that will accompany the notice to be published in the **Federal Register**. Finally, we request that interested parties include footnotes for relevant citations in the public executive summary of each issue.

must certify to the accuracy and completeness of that information. Parties must use the certification formats provided in 19 CFR 351.303(g). Commerce intends to reject factual submissions if the submitting party does not comply with applicable revised certification requirements.

Letters of Appearance and Administrative Protective Orders

Pursuant to 19 CFR 351.103(d), Commerce will maintain and make available a public service list for these proceedings. Parties wishing to participate in any of these five-year reviews must file letters of appearance as discussed at 19 CFR 351.103(d). To facilitate the timely preparation of the public service list, it is requested that those seeking recognition as interested parties to a proceeding submit an entry of appearance within 10 days of the publication of the Notice of Initiation. Because deadlines in Sunset Reviews can be very short, we urge interested parties who want access to proprietary information under administrative protective order (APO) to file an APO application immediately following publication in the **Federal Register** of this notice of initiation. Commerce's regulations on submission of proprietary information and eligibility to receive access to business proprietary information under APO can be found at 19 CFR 351.304–306. Information Required From Interested Parties

Domestic interested parties, as defined in sections 771(9)(C), (D), (E), (F), and (G) of the Act and 19 CFR 351.102(b), wishing to participate in a Sunset Review must respond not later than 15 days after the date of publication in the **Federal Register** of this notice of initiation by filing a notice of intent to participate. The required contents of the notice of intent to participate are set forth at 19 CFR 351.218(d)(1)(ii). In accordance with Commerce's regulations, if we do not receive a notice of intent to participate from at least one domestic interested party by the 15-day deadline, Commerce will automatically revoke the order without further review.²

If we receive an order-specific notice of intent to participate from a domestic interested party, Commerce's regulations provide that *all parties* wishing to participate in a Sunset Review must file complete substantive responses not later than 30 days after the date of publication in the **Federal Register** of this notice of initiation. The required contents of a substantive response, on an order-specific basis, are set forth at 19 CFR 351.218(d)(3). Note that certain information requirements differ for respondent and domestic parties. Also, note that Commerce's information requirements are distinct from the ITC's information requirements. Background

Each year during the anniversary month of the publication of an antidumping duty (AD) or countervailing duty (CVD) order, finding, or suspended investigation, an interested party, as defined in section 771(9) of the Tariff Act of 1930, as amended (the Act), may request, in accordance with 19 CFR 351.213, that the U.S. Department of Commerce (Commerce) conduct an administrative review of that AD or CVD order, finding, or suspended investigation.

All deadlines for the submission of comments or actions by Commerce discussed below refer to the number of calendar days from the applicable starting date.

Respondent Selection

In the event Commerce limits the number of respondents for individual examination for administrative reviews initiated pursuant to requests made for the orders identified below, Commerce intends to select respondents based on U.S. Customs and Border Protection (CBP) data for U.S. imports during the period of review (POR). We intend to release the CBP data under administrative protective order (APO) to all parties having an APO within five days of publication of the initiation notice and to make our decision regarding respondent selection within 35 days of publication of the initiation **Federal Register** notice. Therefore, we encourage all parties interested in commenting on respondent selection to submit their APO applications on the date of publication of the initiation notice, or as soon thereafter as possible. Commerce invites comments regarding the CBP data and respondent selection within five days of placement of the CBP data on the record of the review.

Abstract: A management framework that allows the public to experience the unique winter resources and recreational opportunities at Yellowstone National Park is governed by NPS regulations codified in 36 CFR 7.13, “Yellowstone National Park.” Access to most of the park in the winter is limited by distance and the harsh winter environment which presents challenges to safety and park operations.

In response, the NPS provides opportunities for park visitors to experience Yellowstone in the winter via over-snow vehicles (snowmobiles and snow coaches, collectively OSVs). 36 CFR 7.13 includes provisions that allow greater flexibility for commercial tour operators, provide mechanisms to make the park cleaner and quieter during the winter seasons, reward OSV innovations and technologies, and allow increases in visitation. All OSVs operating in the park are required to meet air and sound emission standards and be accompanied by a guide.

The NPS will use Form 10–650, “OSV Monthly Use Report” to ensure that OSVs meet NPS emission standards to operate in the park. Commercial OSV operators must complete the Form 10–650, “OSV Monthly Use Report” to:

- Transportation Events (§ 7.13(l)(11)(i)–(iii))
- Emission and Sound Standards (§ 7.13(l)(4)(vii) and (5)) and
- Enhanced Emission Standards. (§ 7.13(l)(11)(iv)).

Form 10–650, “OSV Monthly Use Report,” form collects information to: (1) ensure that OSVs meet NPS emission standards to operate in the park; (2) evaluate commercial tour operators’ compliance with allocated transportation events and daily and seasonal OSV group size limits; (3) ensure that established daily transportation event limits for the park are not exceeded; (4) confirm that commercial tour operators do not run out of authorizations before the end of the season and create a gap when prospective visitors cannot be accommodated; and (5) guarantee compliance with applicable laws and regulations.

Steel Concrete Reinforcing Bar From Mexico and Turkey; Institution of Five-Year Reviews

AGENCY: United States International Trade Commission.

ACTION: Notice.

SUMMARY: The Commission hereby gives notice that it has instituted reviews pursuant to the Tariff Act of 1930, as amended, to determine whether revocation of the countervailing duty order on steel concrete reinforcing bar (“rebar”) from Turkey and revocation of the antidumping duty order on rebar from Mexico would be likely to lead to continuation or recurrence of material injury. Pursuant to the Act, interested parties are requested to respond to this notice by submitting the information specified below to the Commission.

DATES: Instituted September 2, 2025. To be assured of consideration, the deadline for responses is October 2, 2025. Comments on the adequacy of responses may be filed with the Commission by November 14, 2025.

SUPPLEMENTARY INFORMATION:

Background.—On November 6, 2014, the Department of Commerce (“Commerce”) issued an antidumping duty order on imports of rebar from Mexico (79 FR 65925) and a countervailing duty order on imports of rebar from Turkey (79 FR 65926). Following the five-year reviews by Commerce and the Commission, effective October 22, 2020, Commerce issued a continuation of the countervailing duty order on imports of rebar from Turkey and the antidumping duty order on imports of rebar from Mexico (85 FR 67334). The Commission is now conducting its second reviews pursuant to section 751(c) of the Act, as amended (19 U.S.C. 1675(c)), to determine whether revocation of the orders would be likely to lead to continuation or recurrence of material injury to the domestic industry within a reasonably foreseeable time. Provisions concerning the conduct of this proceeding may be found in the

Commission's Rules of Practice and Procedure at 19 CFR part 201, subparts A and B, and 19 CFR part 207, subparts A and F. The Commission will assess the adequacy of interested party responses to this notice of institution to determine whether to conduct full or expedited reviews. The Commission's determinations in any expedited reviews will be based on the facts available, which may include information provided in response to this notice.

Definitions.—The following definitions apply to these reviews:

(1) *Subject Merchandise* is the class or kind of merchandise that is within the scope of the five-year reviews, as defined by Commerce.

(2) The *Subject Countries* in these reviews are Mexico and Turkey.

(3) The *Domestic Like Product* is the domestically produced product or products which are like, or in the absence of like, most similar in characteristics and uses with, the *Subject Merchandise*. In its original determinations and full first five-year review determinations, the Commission defined a single *Domestic Like Product* that was coextensive with Commerce's scope.

(4) The *Domestic Industry* is the U.S. producers as a whole of the *Domestic Like Product*, or those producers whose collective output of the *Domestic Like Product* constitutes a major proportion of the total domestic production of the product. In its original determinations and first full five-year review determinations, the Commission defined the *Domestic Industry* as all domestic producers of the *Domestic Like Product*.

(5) An *Importer* is any person or firm engaged, either directly or through a parent company or subsidiary, in importing the *Subject Merchandise* into the United States from a foreign manufacturer or through its selling agent.

Kitchen Appliance Shelving and Racks From China; Institution of a Five-Year Review

AGENCY: United States International Trade Commission.

ACTION: Notice.

SUMMARY: The Commission hereby gives notice that it has instituted reviews pursuant to the Tariff Act of 1930, as amended, to determine whether revocation of the countervailing and the antidumping duty orders on kitchen appliance shelving and racks from China would be likely to lead to continuation or recurrence of material injury. Pursuant to the Act, interested parties are requested to respond to this notice by submitting the information specified below to the Commission.

DATES: Instituted September 2, 2025. To be assured of consideration, the deadline for responses is October 2, 2025. Comments on the adequacy of responses may be filed with the Commission by November 14, 2025.

SUPPLEMENTARY INFORMATION:

Background.—On September 14, 2009, the Department of Commerce ("Commerce") issued antidumping and countervailing duty orders on imports of certain kitchen appliance shelving and racks from China (74 FR 46971). Commerce issued a continuation of the antidumping and countervailing duty orders on imports of certain kitchen appliance shelving and racks from China following Commerce's and the Commission's first five-year reviews, effective March 12, 2015 (80 FR 12983) and second five-year reviews, effective October 15, 2020 (85 FR 65345). The Commission is now conducting its third five-year reviews pursuant to section 751(c) of the Act, as amended (19 U.S.C. 1675(c)), to determine whether revocation of the orders would be likely to lead to continuation or recurrence of material injury to the domestic industry within a reasonably foreseeable time. Provisions concerning the conduct of this proceeding may be found in the Commission's Rules of Practice and Procedure at 19 CFR part 201, subparts A and B, and 19 CFR part 207, subparts A and F. The Commission will assess the adequacy of interested party responses to this notice of institution to determine whether to conduct full or expedited reviews. The Commission's determinations in any expedited reviews will be based on the facts available, which may include information provided in response to this notice.

Definitions.—The following definitions apply to these reviews:

(1) *Subject Merchandise* is the class or kind of merchandise that is within the scope of the five-year reviews, as defined by Commerce.

(2) The *Subject Country* in these reviews is China.

(3) The *Domestic Like Product* is the domestically produced product or products which are like, or in the absence of like, most similar in characteristics and uses with, the *Subject Merchandise*. In its original determinations and its expedited first and second five-year review determinations, the Commission found two *Domestic Like Products*: (1) certain refrigeration shelving and baskets for refrigerators, freezers, combination refrigerator/freezers and other refrigerating or freezing equipment ("refrigeration shelving"); and (2) certain oven racks, side racks, and subframes for cooking stoves, ranges, and ovens ("oven racks").

(4) The *Domestic Industry* is the U.S. producers as a whole of the *Domestic Like Product*, or those producers whose collective output of the *Domestic Like*
