İlgi yazımızda, Avustralya'nın Dünya Ticaret Örgütü (DTÖ) Sağlık ve Bitki Sağlığı (SPS) Önlemlerinin Uygulanmasına İlişkin Anlaşma kapsamında yaptığı 01.07.2021 tarihli G/SPS/N/AUS/502/Add.11 simgeli bildirimin 6A aşamasını kapsadığına dair detaylı bilgiler paylaşılmıştır.

**03.08.2021** tarihli **G/SPS/N/AUS/502/Add.12** simgeli ekli SPS bildiriminde; acil durum önlemlerinin 3. Aşaması kapsamında yüksek riskli bitki ürünleri için mevcut olan geçici alternatif işlem seçenekleri hakkında ticaret ortaklarını bilgilendirmek amacıyla yayımlandığı belirtilmiştir. Geçici alternatif işlemleri ise şu şekildedir:

-Acil durum önlemlerinin 3. aşamasının Eylül 2021'de başlatılacağı belirtilmiş olup hava ve deniz yoluyla T. granarium hedefinde olma riski olan bir ülkeden ihraç edilen yüksek riskli bitki ürünleri için onaylanmış bir seçenek kullanılarak, sınır ötesinde zorunlu işlemler gerçekleştirilmeye başlanacağı bildirilmektedir.

-Onaylı işlem seçeneklerinin ısıl işlem ve metil bromür fümigasyonu olduğu belirtilmekte olup bu seçeneklerin bazı ürünler için uygun olmadığı bildirilmektedir. Bu nedenle modifiye atmosfer uygulamaları da dahil olmak üzere alternatif işlem seçenekleri belirtilmiştir. Bu seçeneklerin yalnızca geçici önlem olduğundan bahsedilmiştir. Yüksek riskli bitki ürünleri için mevcut alternatif işlem seçeneklerini detaylandıran belge aşağıdaki linkte bulunmaktadır.

03.08.2021 tarihli G/SPS/N/AUS/502/Add.13 simgeli ekli SPS bildiriminde ise 2 Ağustos 2021'de veya sonrasında ithal edilen bitki ürünlerinin artık yüksek riskli olarak kabul edilmediği belirtilmiş olup istisnalar listesi web sitesinde bulunmaktadır.

Ayrıca 23.08.2021 tarihli G/SPS/N/AUS/502/Add.14 simgeli ekli SPS bildirimi yayımlanmıştır. 30 Eylül 2021 ve sonrasında ihraç edilen yüksek riskli bitkisel ürünler için yeni ithalat koşullarının geçerli olacağı ve ithalat koşullarının, ihracatın yapıldığı ülkeye göre farklılık göstereceği belirtilmiştir.

The following communication, received on 29 July 2021, is being circulated at the request of the Delegation of <u>Australia</u>.

Emergency measures to safeguard Australia against the entry, establishment and spread of khapra beetle (*Trogoderma granarium*): Provisional alternative treatment options available for high-risk plant products

On 4 August 2020, Australia issued a SPS notification (G/SPS/N/AUS/502) informing trading partners of its intention to implement emergency measures to safeguard Australia against the entry, establishment and spread of khapra beetle (*Trogoderma granarium*). The emergency measures are being implemented in phases and will result in changes to import conditions for plant products and sea containers.

This addendum is to notify trading partners of provisional alternative treatment options available for high-risk plant products under Phase 3 of the emergency measures.

### Provisional alternative treatment options:

Phase 3 of the emergency measures will commence in September 2021. It will introduce mandatory offshore treatment using an approved option for high-risk plant products exported from a khapra beetle target risk country, via all commercial air and sea pathways.

Approved treatment options are heat treatment and methyl bromide fumigation. We recognise these options are not feasible for some products. As such, we have considered alternative treatment options including modified atmosphere treatments.

We have published a document on our website detailing alternative treatment options available for high-risk plant products. These options are provisional measures only. Provisional measures are subject to change as further data and information becomes available.

We are continuing to engage with peak industry bodies on the alternative treatment options.

The following communication, received on 3 August 2021, is being circulated at the request of the Delegation of <u>Australia</u>.

### Notification of emergency measures for Khapra Beetle

On 4 August 2020, Australia issued a SPS notification (G/SPS/N/AUS/502) informing trading partners of its intention to implement emergency measures to safeguard Australia against the entry, establishment and spread of khapra beetle (*Trogoderma granarium*). The emergency measures are being implemented in phases and will result in changes to import conditions for plant products and sea containers. This addendum is to notify trading partners of updates to the exclusion list for high-risk plant products.

#### Exclusion list:

The exclusion list of high-risk plant products is relevant to khapra beetle emergency measures under Phases 1 to 3 and Phase 6A part 1.

The following plant products exported on or after 2 August 2021 are no longer considered high-risk:

- Commercially prepared and packaged goods that have been thermally processed so that the nature of the material has been transformed from their original raw form.
- Goods that are commercially milled or ground to a powder, meal or flakes and packaged in bags less than 25kg.

Note: these goods do not require mandatory treatment from khapra beetle target risk countries but commercial consignments will require a phytosanitary certificate verifying freedom from khapra beetle.

- Breakfast cereals, instant cereal beverage mixes, couscous meal mixes and snack foods that are commercially prepared and retail packaged. \*
- Bakery and bread mixes (including whole seeds) that are commercially prepared and retail packaged.\*
- Commercially prepared and packaged herbal teas, with or without seeds (including loose leaf and tea bags).
- \* An imported good is considered retail packaged if it has been commercially prepared and packaged overseas and is in a final state that requires no further processing, packaging or labelling prior to sale or use in Australia.

Note: The exclusion list for other risk plant products has also been updated. However, this list only

applies to Phase 4 of the emergency measures which has been placed on hold.

The following communication, received on 23 August 2021, is being circulated at the request of the Delegation of <u>Australia</u>.

### Notification of emergency measures for khapra beetle

On 4 August 2020, Australia issued a SPS notification (G/SPS/N/AUS/502) informing trading partners of its intention to implement emergency measures to safeguard Australia against the entry, establishment and spread of khapra beetle (*Trogoderma granarium*). The emergency measures are being implemented in phases and will result in changes to import conditions for plant products and sea containers. This addendum is to notify trading partners of updates to import conditions for high-risk plant products imported via all commercial pathways.

New import conditions will apply to high-risk plant products exported on or after 30 September 2021. Import conditions will differ depending on the country of export.

Note: The new import conditions do not apply to seeds for sowing and goods that are imported for research purposes coming as low value freight (less than AUD\$1000).

These enhanced import conditions for high-risk khapra beetle products are in addition to measures introduced for sea containers in April 2021.

### Khapra beetle target risk countries

High-risk plant products exported from khapra beetle target risk countries (<a href="https://www.agriculture.gov.au/import/arrival/pests/khapra beetle">https://www.agriculture.gov.au/import/arrival/pests/khapra beetle</a>) via sea and air freight will need to be treated offshore with an approved treatment option and inspected by a government official of the exporting country.

Approved treatment options are heat treatment, methyl bromide fumigation and modified atmosphere treatments. In addition to a treatment certificate, the goods must be treated within 21 days of export and be accompanied by a phytosanitary certificate certifying treatment requirements have been met and that the goods are free from all live species of *Trogoderma*.

Note: Modified atmosphere treatments are a provisional option only. As such, an import permit is required. The goods must have an import permit before they arrive in Australia

## All other countries

High-risk plant products exported from all other countries via sea and air freight will need to be inspected by a government official of the exporting country and certified as free from evidence of any species of *Trogoderma* that are of concern to Australia (the list of *Trogoderma* species of

concern can be found via <a href="https://www.agriculture.gov.au/pests-diseases-weeds/plant/khapra-beetle">https://www.agriculture.gov.au/pests-diseases-weeds/plant/khapra-beetle</a>).

Failure to comply with these requirements may result in the export of the container and/or goods upon arrival in Australia.

## Other updates

Please note, the Definition of high-risk plant products list on Australia's urgent actions website has been updated to exclude goods that are commercially processed to a powder, meal or flakes and packaged in bags less than or equal to 25 kgs (such as cereal flours like semolina, wheat flour, chilli flakes and ground spices).
